To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we conduct internal training on Our Code – How We Act, including both face to face and web-based training.

Grievance mechanisms

Everyone working at, or with, Volvo Car UK Limited should be comfortable raising questions or concerns about ethical issues or cases of non-compliance. We support a culture of openness, integrity and accountability. Volvo Car UK Limited offers the possibility to report serious violations of Our Code – How We Act via the <u>Tell-us reporting line</u> where employees and others can submit reports confidentially and anonymously.
